Committee Reports:

ABRA Committee:

Elwyn Ferris, Chair, updated membership on the status of the "Street" Tavern license application at 1346 T Street (former Café Collage) as a result of the February 19th Roll Call Hearing, as follows: There are three distinct protestant groups: A resident protest group consisting of 14 residents; an abutting property owner; and a local civic association, SDCA, upon re-submission of incorporation documents and letter of representation. Incorporation documents were re-submitted to ABRA later in the same afternoon of Feb. 19th.

Elwyn Ferris clarified information disseminated by ABRA representatives at the Feb. 20th ANC1B ABC Committee meeting, regarding the new definition of "overconcentration" as defined in the new Omnibus Bill, currently being applied to all pending applications and the moratorium request for 14th and U Street, as follows:

(35A) "Overconcentration" means the existence of several licensed establishments that adversely affect a specific locality, section or portion of the District of Columbia, including consideration of the appropriateness standards under (section) 25-313(b)

ABC License Applications:

ABRA Lic. #091244; Class "T" Tavern; "Fainting Goat"; 1330 U Street NW:

Owner and proprietor Henry Bruce presented a plan and distributed hand-outs for a new tavern at 1330 U Street NW:

Nature of Operation:

New tavern serving appetizers, burgers, sandwiches, salads, and main courses. Featuring a DJ and background music. Occupancy load of 199.

Hours of Operation:

Sunday through Thursday 8 am – 2 am, Friday and Saturday 8 am – 3 am.

Hours of Entertainment:

Sunday through Thursday 6 pm – 2 am, Friday and Saturday 6 pm – 3 am

Motion by Elwyn Ferris, to file a formal Protest of this application based on its negative impact on peace, order and quiet; vehicular and pedestrian safety; over-concentration of alcohol licenses; and parking concerns. Seconded by Robert Lawrentz. Vote: 5-0-0
